Preferred Wording of NAWMP Plan Purpose

The purpose of the Plan is to sustain abundant waterfowl populations through habitat conservation while preserving the traditions of wildfowling and achieving broad benefits to biodiversity, ecosystem processes and the people of North America.

Preferred Wording of SDM Problem Statement

Key habitats continue to experience pressures that affect their capacity to support abundant waterfowl, compelling the waterfowl community to develop and achieve habitat objectives in a manner that is more explicitly-linked to waterfowl populations.

(Alternate wording) NAWMP should remain focused on waterfowl habitat programs, and the waterfowl conservation community needs to develop additional frameworks to integrate waterfowl harvest management programs and support waterfowl hunting traditions more effectively.
